### THE CHEVALIER AWARD - 2016

### TO: All Candidates for the Award

As the son or daughter of an employee of a member company of the Canadian Consumer Specialty Products Association, you are invited to participate in the competition for the Chevalier Award and the accompanying sum of \$2,500.00.

The late Jacques Chevalier served the association as Executive Director for about 30 years, retiring in 1988. He carried out his responsibilities with distinction and competence, but his warm personality, high ideals and sense of commitment infused the association with a spirit of "family." He did all that was required to be done very well, but he consistently went beyond that and gave of himself in a way that enriched our association and the lives of those he touched. In this he was ably assisted and encouraged by his wife, the late Jessie Chevalier.

The purpose of this award is:

- A) To draw to the attention of students at University level in engineering and physical sciences courses that the opportunity of a university education provides more than academic challenge, and
- B) To recognize the student whose extracurricular contributions and accomplishments have been outstanding, and
- C) In so doing, to fittingly honour the memory and achievements of Jacques and Jessie Chevalier.

We hope you will feel this award represents an honour to which the monetary reward is secondary.

We know many of you possess the qualities and have fulfilled the requisites of the Chevalier Award. We want you to tell us about it. We want you to apply for our award. For full details of qualifications, refer to the "criteria for qualification" in the Chevalier Award descriptive document.

The application form is enclosed and must be received into the Ottawa office of the CCSPA association by July 8, 2016. A selection committee will review it and the successful candidate will be notified in writing by August 5. The cash amount of the award will be forwarded to the student awards officer at the appropriate institution by August 18, 2016.

The award plaque will be presented to the student at an official luncheon during the CCSPA's conference in September in Toronto, Ontario, and he/she will have the opportunity to give a 3-minute response.

### THE CHEVALIER AWARD - 2016

### **OBJECTIVES**

To extend recognition to the late Jacques and Jessie Chevalier for their assistance in shaping and guiding the destiny of the CCSPA association for almost 30 years.

We respect their memory in the form of an award to be presented annually to a qualifying student.

### **CRITERIA FOR QUALIFICATION**

- 1. A full student under 25 years of age attending a degree-granting university or college, the student must be primarily resident in Canada and must have completed at least one year in a physical science course or an engineering faculty.
- 2. Emphasis will be placed upon recognizing and fostering academic merit (minor consideration may be given to financial need). The student must provide scholastic and extra curricular records which are acceptable to the selection committee, augmented by:
- a) Evidence of good citizenship, humanitarian service, and interest in communal affairs;
- b) Evidence of leadership skills;
- c) A display of high energy level and motivation which exemplify the distinguished qualities and ideals of the late Jacques and Jessie Chevalier.
- 3. The student must be a son, daughter, or dependent of an eligible employee of a CCSPA "active member" company at the time the award is approved by the selection committee. Eligible employees may include those who are recently (within one year) deceased, disabled or retired.
- 4. The student, unless graduating, will be required to provide proof of acceptance into an appropriate course for the next academic year and will be expected to remain in good disciplinary standing in his or her chosen institution.
- 5. a) Under normal conditions, the award will be presented to a qualified applicant each year unless no suitable applications have been received.
  - b) The award will not be issued to a deserving candidate more than once.
  - c) Candidates are encouraged to reapply as long as all criteria are met.

### 6. The attached "CONSENT STATEMENT FOR CCSPA CHEVALIER AWARD 2016" <u>must</u> be read and signed by the applicant and <u>must</u> be returned with the application.

### **ADMINISTRATION**

- 1. Applications, completed as required, must be received each year into the Ottawa office of the CCSPA association postmarked no later than July 8, 2016.
- 2. The award will be accompanied by an amount of \$2,500.00 Canadian funds payable to the Awards Officer (in trust) of the university or institution in which the chosen applicant is enrolled.
- A final decision of the successful applicant will be forthcoming from the selection committee no later than July 29. The successful candidate will be notified in writing by the CCSPA office by August 5. The amount of the award will be forwarded to the Student Awards Officer of the university or college by August 18, 2016.

4. A commemorative plaque will be presented to the student at a luncheon during the CCSPA's Conference and he or she will have the opportunity to give a 3-minute response.

### CANADIAN CONSUMER SPECIALTY PRODUCTS ASSOCIATION POLICY CONCERNING THE PROTECTION OF PERSONAL INFORMATION

#### Introduction

The Canadian Consumer Specialty Products Association ("CCSPA") is a national trade association representing the consumer, industrial and institutional specialty products industry. CCSPA may collect Personal Information in the course of its activities and has prepared this policy to inform you about our ongoing commitment to ensuring that the Personal Information obtained remains accurate and confidential.

#### What is Personal Information?

We consider "Personal Information" to mean any information, recorded in any form, about an identified individual or an individual whose identity may be inferred or determined from such information, other than business contact information (e.g. name, title, business address). This Policy does not cover business contact information or aggregated data from which the identity of an individual cannot be determined. CCSPA retains the right to use business contact information and aggregated data in any way that it determines appropriate.

#### Why CCSPA May Collect Personal Information

CCSPA may use the Personal Information you provide verbally or in writing (including via electronic media) in order to:

- Establish a commercial relationship with you;
- Provide you with our products and services;
- Provide you with ongoing customer service;
- Provide you with information about our products and services (including by means of direct marketing);
- Process payments for products and services;
- For ongoing administration of memberships;
- Meet legal and regulatory requirements; and
- Such other purposes consistent with these purposes.

The personal information we ask for will depend upon which products or services you may obtain.

### How CCSPA Collects and Uses Personal Information

CCSPA only collects, uses and discloses Personal Information for purposes that would be considered reasonable in the circumstances and only such information as is required for the purposes of providing products or services to our clients. We use only fair and lawful methods to collect Personal Information.

Our use of Personal Information is limited to the purposes described in this Policy and CCSPA does not otherwise sell, trade, barter, exchange or disclose for consideration any Personal Information it has obtained.

#### When CCSPA May Disclose Your Personal Information

CCSPA may disclose your Personal Information to:

• Individuals or organizations who are our advisers or service providers; and

 Individuals or organizations who are, or may be, involved in maintaining, reviewing and developing our business systems, procedures and infrastructure including testing or upgrading our computer systems

In the event sensitive Personal Information is provided to CCSPA, we will not disclose such Personal Information unless it is required in order to provide you with our products or services.

Where CCSPA discloses Personal Information to organizations that perform services on its behalf, we will require those service providers to use such information solely for the purposes of providing services to CCSPA, our clients or the person concerned and to have appropriate safeguards for the protection of that Personal Information.

CCSPA may disclose personal information to a service provider which is located in the United States where privacy laws may offer different levels of protection from those in Canada. Your personal information may also be subject to access by and disclosure to law enforcement agencies under American legislation such as the USA Patriot Act.

Please note that there are circumstances where the use and/or disclosure of Personal Information may be justified or permitted or where CCSPA is obliged to disclose information without consent. Such circumstances may include:

- Where required by law or by order or requirement of a court, administrative agency or governmental tribunal;
- Where CCSPA believes, upon reasonable grounds, that it is necessary to protect the rights, privacy, safety or property of an identifiable person or group;
- Where it is necessary to establish or collect monies owing to CCSPA;
- Where it is necessary to permit CCSPA to pursue available remedies or limit any damages that we may sustain; or
- Where the information is public.

Where obliged or permitted to disclose information without consent, CCSPA will not disclose more information than is required.

### Consent

Unless permitted by law, no Personal Information is collected, without first obtaining the consent of the individual concerned to the collection, use and dissemination of that information. However, we may seek consent to use and disclose Personal Information after it has been collected in those cases where we wish to use the information for a new or different purpose where the individual concerned has not already consented to such a use of their personal information.

By providing Personal Information to CCSPA you agree and consent that we may collect, use and disclose your Personal Information in accordance with this Policy. In addition, where appropriate, specific authorizations or consents may be obtained from time to time.

In most cases and subject to legal and contractual restrictions, you are free to refuse or withdraw your consent at any time upon reasonable, advance notice. It should be noted that in certain circumstances, products or services can only be offered if you provide Personal Information to CCSPA. Consequently, if you choose not provide us with any required Personal Information, we may not be able to offer you the products or services requested. We will inform you of the consequences of the withdrawal of consent.

### The Accuracy And Retention Of Personal Information

CCSPA endeavors to ensure that any Personal Information provided and in its possession is as accurate, current and complete as necessary for the purposes for which we use that information. If we become aware that Personal Information is inaccurate, incomplete or out of date, CCSPA will revise the Personal Information and, if necessary, use its best efforts to inform third parties which were provided with inaccurate information so that those third parties may also correct their records.

We keep your Personal Information only as long as it is required for the reasons it was collected. The length of time we retain information varies, depending on the purpose for which it was collected and the nature of the information. This period may extend beyond the end of your relationship with us but it will be only for so long as it is necessary for us to have sufficient information to respond to any issues that may arise at a later date.

When your Personal Information is no longer required for CCSPA's purposes, we have procedures to destroy, delete, erase or convert it into an anonymous form.

#### **Protection of Personal Information**

CCSPA endeavours to maintain appropriate physical, procedural and technical security with respect to its offices and information storage facilities so as to prevent any loss, misuse, unauthorized access, disclosure, or modification of Personal Information. This also applies to our disposal or destruction of Personal Information.

CCSPA further protects Personal Information by restricting access to it to those employees that the management of CCSPA has determined need to know that information in order that we may provide our products.

If any employee of CCSPA misuses Personal Information, this will be considered as a serious offence for which disciplinary action may be taken, up to and including termination of employment. If any individual or organization misuses Personal Information - provided for the purpose of providing services to or for CCSPA - this will be considered a serious issue for which action may be taken, up to and including termination of any agreement between CCSPA and that individual or organization.

### **Access To Your Personal Information**

CCSPA permits the reasonable right of access and review of Personal Information held by us about an individual and will endeavour to provide the information in question within a reasonable time, generally no later than 30 days following the request. To guard against fraudulent requests for access, we may require sufficient information to allow us to confirm that the person making the request is authorized to do so before granting access or making corrections.

We will provide information from our records in a form that is easy to understand. CCSPA reserves the right not to change any Personal Information but will append any alternative text the individual concerned believes to be appropriate.

CCSPA reserves the right to decline to provide access to Personal Information where the information requested:

- Would disclose (i) Personal Information, including opinions, about another individual or about a
  deceased individual; or (ii) trade secrets or other business confidential information that may harm
  CCSPA or the competitive position of a third party;
- Would interfere with contractual or other negotiations of CCSPA or a third party;
- Is subject to solicitor-client, litigation or other legal privilege;
- Is not readily retrievable and the burden or cost of providing would be disproportionate to the nature or value of the information;
- Does not exist, is not held, or cannot be found by CCSPA;
- May harm or interfere with law enforcement activities and other investigative or regulatory functions of a body authorized by law to perform such functions; or
- May be withheld or is requested to be withheld under applicable legislation.

Where information will not or cannot be disclosed, the individual making the request will be provided with the reasons for non-disclosure.

CCSPA will not charge you for verifying or correcting your information, however, to the extent permitted by applicable law, there may be a minimal charge imposed if you need a copy of records.

### **Resolving Your Privacy Concerns**

CCSPA will investigate all complaints and if a complaint is justified, we will take all reasonable steps to resolve the issue.
