- Approve changes to specifications, standard operating procedures, labels, and marketing literature in accordance to internal procedures, policies, and regulatory requirements.
- Provide guidance to project teams regarding application of regulatory requirements in Canada.
- Author and submit annual reports to Health Canada for applicable products.
- Conduct reviews of product complaints and submit reportable adverse events/incidents and recall documentation to Health Canada.
- Participate in audits/inspections conducted by regulatory agencies. Manage timely responses to agency requests.
- Partner with external trade organizations such as CCSPA to influence regulatory policy.
- Collect and report regulatory intelligence for applicable businesses.
- Actively engage internal and external stakeholders on regulatory matters.
